

THE PRESIDENTS' AWARD

The award will be presented by Ecclesiastical Architects and Surveyors Association in conjunction with the Incorporated Church Building Society at the EASA AGM. The award will be given for new design in re-ordering, alterations, extensions or new buildings which are specifically for liturgical use.

EASA has been working with the ICBS since this award was first awarded in 1999. The designers apply with a written endorsement from the Parish.

The work of the ICBS in association with the EASA will be carried forward year on year by the presentation of this Award.

ICBS will present their own Chalice and Paten on loan to the Church for which the winning scheme has been designed. This Chalice and Paten was commissioned by the ICBS and made after the 2nd world war. At that time the Society was able to loan them to a new or seriously war damaged Church until the Parish was in a position to commission its own or replace those that had been lost. These treasures are now being used again to encourage new design for the future.

The rules and conditions are set out below and the Application Form is on the reverse. **The deadline date is 10am on Tuesday 4th October 2011.** Accompanying information should include a written description of the project, supported by drawings and photographs. This material must be mounted on not more than two landscape A2 size display boards and be submitted digitally (on CD or DVD in PDF format) as well as in hard copy.

RULES AND CONDITIONS

1. The Presidents' Award will be presented annually for new work undertaken for the enhancement of Christian worship. Eligible work will be re-ordering schemes, alterations and extensions including new Churches.
2. The Award will be given to the best example of new work at the discretion of the judging panel and will be presented at the Annual General Meeting of the EASA in London, in November.
3. The submission will be displayed at the presentation ceremony at the AGM of the Ecclesiastical Architects and Surveyors Association the following November, and such other meetings as may be held throughout the ensuing year.
4. The winning Parish will be presented with the ICBS Chalice and Paten to be held by them from the presentation until the EASA AGM the following year, by which date they are to be returned to 31 Newbury Street, London EC1A 7HU. The winning Architect or Surveyor is required to give a short presentation regarding the work at the EASA AGM.
5. Projects will be eligible if they have been completed within the last three years or after the Practical Completion stage in their development. They will be assessed by the President of the EASA, the Chairman of the ICBS, nominees of the NCT and nominees of EASA.
6. Applications for the Award are to be made by the designer of the scheme with the endorsement of the PCC. Entries will be retained for the following 12 months for the purposes of exhibition.
7. Application Forms are to be completed and accompanied by a description of the work, drawings of the project and photographs illustrating progress and completion and are to be presented on not more than two landscape A2 boards in hard copy and digitally. This material is to be received **on or before 10am Tuesday 4th October 2011** at 31 Newbury Street, London EC1A 7HU where the judging is to take place.
8. Please note that we encourage all applicants to advise us of whom they would like informing of their success to ensure that your patrons are made aware of the quality of your work and the accolades it receives.
